

#### **Details of the Schemes**

1. "Establishment of National Institute of Paramedical Sciences(NIPS)/National Institute for Allied Health Sciences(NIAHS) and Eight Regional Institute of Paramedical Sciences(RIPS)/Regional Institute for Allied Health Sciences (RIAHS) and supporting the State Govt. Medical Colleges for conducting paramedical courses through one time grant".

The scheme has two components:-

- a. Establishment of One National Institute of Paramedical Sciences (NIPS)/NIAHS at Najafgarh, Delhi and eight Regional Institute of Paramedical Sciences (RIPS)/RIAHS at Bhagalpur (Bihar), Bhopal (Madhya Pradesh), Bhubaneswar (Orissa), Chandigarh, Coimbatore (Tamil Nadu), Hyderabad (Andhra Pradesh), Lucknow (Uttar Pradesh) and Nagpur (Maharashtra).
- b. To support State Govt. Medical Colleges conducting paramedical courses through one time grant.

# 2. Setting up of State institutions of paramedical sciences in States and setting up of college of paramedical education.

Ministry of Health & Family Welfare, Government of India is planning to launch a Centrally Sponsored Scheme i.e. "Setting up of institutions of paramedical sciences in States and Setting up of college of paramedical education" for enhancing the availability of Allied Health Professionals

Tentative allocation of a state will be around Rs. 20 crores for commencement of new courses and increasing the intake capacity of the existing courses. The grant-in-aid will be provided in two equal installments. State Governments have to contribute 15% of the total grant-in-aid provided to them.

The State Government Medical Colleges where surplus faculty, infrastructure and other facilities are available, where existing courses could be enhanced to improve the availability of Allied Health Professionals and new paramedical courses can be started with minimum efforts and time.

#### 3. "Strengthening/ Up-gradation of Pharmacy Institutions".

The Scheme has four components: -

- a. Strengthening/ Up-gradation of at least 10 Govt. Diploma level Institutions with need based assistance upto Rs.3 crores to enable them to run B.Pharma courses with an outlay of Rs.30 crores.
- b. Strengthening/ Up-gradation of at least 15 Govt. Degree level Institutions with need based assistance upto Rs.2 crores to enable them to run M.Pharma courses in at least one specialization with an outlay of Rs.30 crores.
- c. Continuing Education Programme for faculty with an outlay of Rs.15 crores.
- d. Continuing Education Programme for practicing pharmacists with an outlay of Rs.10 crores.

# 4. Setting up of college of Pharmacy in Government Medical Colleges.

A new scheme namely "Setting up of college of pharmacy in Government Medical Colleges" has been proposed for implementation in 12<sup>th</sup> Plan. In this Rs. 824.30 crore has been allocated in the 12<sup>th</sup> Plan and Rs. 26.65 crore in the financial year 2013-14. The proposal of the Govt. for establishment of college of pharmacy in Govt. Medical College is in the interest of Pharmacy Profession and the Pharmacy Council of India fully supports the same. Such a move will: -

- a. Enable the deserving students to get quality education.
- b. Ensure the availability of skilled competent pharmacist workforce to the society.
- c. Create job opportunities for pharmacy teachers.
